Dear Member:

Rockland Employees Federal Credit Union will hold its annual meeting on May 21<sup>st</sup>, 2026 at the Finkelstein Library, 24 Chestnut Street, Spring Valley, NY. The annual meeting will start at 5:00 P.M.

All elections shall be determined by a plurality vote and shall be by ballot boxes, except where there is only one nominee for each position to be filled. Nomination shall not be made from the floor, unless sufficient nominations have not been made by the nominating committee or by petition to provide for one nominee for each position to be filled, or circumstances prevent the candidacy of the one nominee for a position to be filled. Only those positions without a nominee shall be subject to nomination from the floor. In the event nominations from the floor, where permitted herein, result in more than one nominee for a position to be filled, and when the nominations have been closed, tellers shall be appointed by the president, ballots shall be distributed, and the vote shall be taken and tallied by the tellers and the results announced. When only one member is nominated for each position to be filled, the Chair shall take a voice vote or declare each nominee elected by general consent or acclamation at the annual meeting.

Members who are in good standing, have been a member for the past 3 years, are at least 18 years of age, agree to sign a Statement of Conduct, complete a Statement of Disclosure Form and agree to a bondability check; are entitled to run for any open Board of Directors positions. If you wish to do so, you need to submit a Nominee Application Form which can be obtained at any branch of the Credit Union. The form must be filled out in English and contain a brief statement of not more than 175 words of how you intend to contribute to the Credit Union, a recitation of your education and professional background, and other important biographical information. The forms may be delivered to any Credit Union Office or mailed to the Credit Union at 170 East Central Avenue, Spring Valley, New York 10977, Att: Nominating Committee, no later than forty (40) days prior to the annual meeting.
